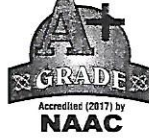

It is hereby notified for the information of all concerned that the Academic Council, at its 55th meeting held on 26-3-2018 considered the recommendations of 20th Board of Examinations held on 28-12-2017 regarding rules and amendments for award of Gold Medals to meritorious students and resolved as follows :

- The student of each Degree Programme who has passed the examination with the highest number of marks among the successful students be awarded a Gold Medal. If a Degree Programme includes more than one specialization, a Gold Medal be given to the student securing the highest number of marks among the students of different specializations taken together.
- Gold Medal shall be awarded to the students who have passed diploma examination (both UG and PG) at the 19th convocation only.
- But for the 20th convocation and onwards, Gold medals shall not be awarded to the students who have passed Diploma examinations (both at UG and PG level). Such a student securing the highest number of marks in a Diploma examination (UG or PG) be given Silver medal worth Rs. 1000/-. This award and the certificate of merit be awarded to such students at suitable functions organized in the respective institutions.

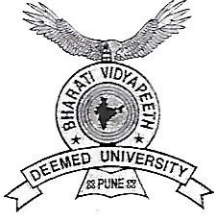

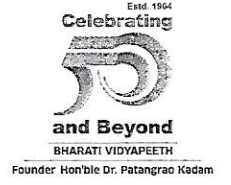

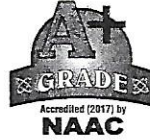
