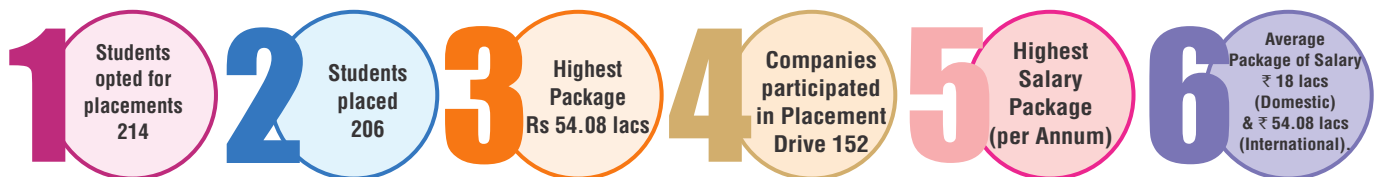

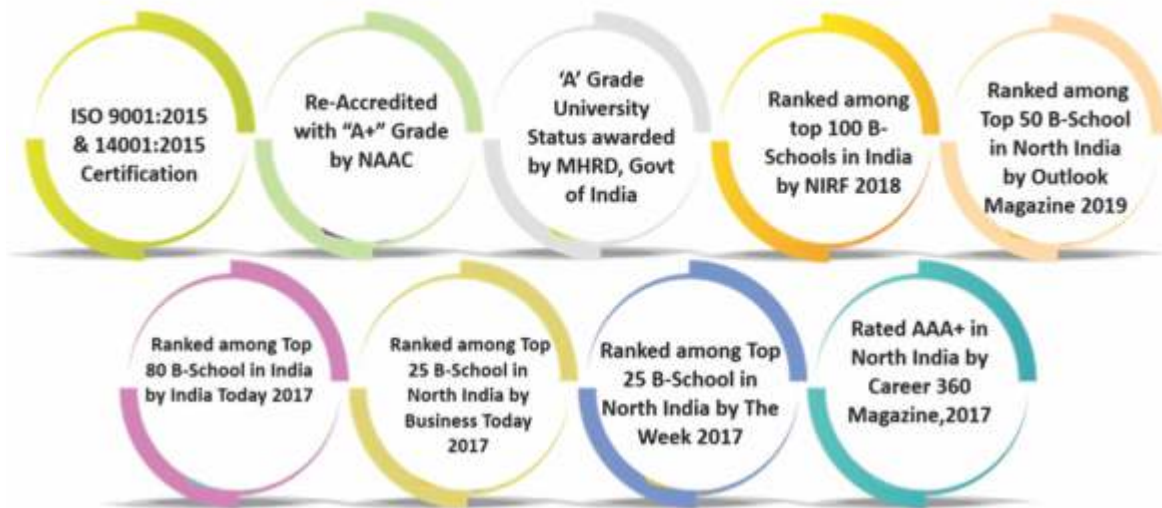

The seat will be allotted to the candidate who has secured highest marks in the entrance test among J & K candidates.

**Note :** 15% seats are reserved under Foreign / NRI /PI.O. / OCI/ Institutional Quota Merit Category. Candidates seeking admissions to the seats under Foreign / NRI /PI.O. / OCI/ Institutional Quota Merit category will have to apply separately on a prescribed application form and submit the same to The Registrar, Bharati Vidyapeeth (Deemed to be University), Pune. The form fee for this category is **Rs. 1,000/- (non refundable)**. Seats remaining vacant after allotment to Foreign / NRI / PI.O./ OCI Students (based on Merit), will be allotted to Indian students under Institutional Quota on the basis of merit based on the marks obtained by them in **BUMAT 2023**. The last date for submission of form to this category is **8th June 2023 before 5.00 p.m.**

## 2. ELIGIBILITY

- (i) A candidate applying for the BBA/BCA Programme should have passed HSC (10+2) or equivalent examination from any statutory board situated in India.

The candidates who have appeared at the qualifying examination are also eligible to apply provided they complete their examination including practical Examinations, viva / assignments on or before the day of admission to the institute of their choice. The admission of student, will remain provisional until the necessary certificates in original, are submitted to the institute. The last date to submit all the certificates in original shall be **30th, September 2023**, if certificates are not submitted by the said date or the eligibility is not granted, the admission would automatically stand cancelled. Under no circumstances will an extension of the deadline be made.

## 3. BASIS OF SELECTION FOR ADMISSION

- 3.1 A Candidate desirous of seeking admission to BBA/BCA Programme should fulfill the minimum eligibility condition as stated in **point no 2**, above.
- 3.2 He/She must have appeared for computer center based entrance Test **BUMAT-2023** conducted by Bharati Vidyapeeth (Deemed to be University), Pune at designated centres.
- 3.3 The Candidate shall be offered admission on the basis of his/her rank in the final merit list and availability of the seats for a particular programme at a particular Institute of the candidate's choice at the time of counseling and admission in the concerned Institute. Mere appearance in the computer center based entrance test and inclusion of name in the merit list does not confer any automatic rights to secure admission to the programme offered by the institute. The selection and admission to the programme is subject to fulfilling the eligibility criteria.
- 3.4 In the case of candidates securing equal aggregate marks their relative rank will be determined on the basis of following order of preference:
- If equal, the candidates will be ranked according to their percentage of marks obtained at HSC or its equivalent examination.
  - If equal, the candidates will be ranked according to their percentage of marks scored at SSC or its equivalent examination.
  - When all the above scores are the same, the candidates will be ranked on the basis of computerized random numbering.

## 4. NATURE OF COMPUTER CENTER BASED ENTRANCE TEST : BUMAT-2023

- 4.1 The **BUMAT-2023** is a computer center based entrance test for admission to BBA/BCA programme. It will be of 200 marks and shall be of 150 minutes duration.
- 4.2 The **BUMAT-2023** Test will be of in all, 200 marks. It will consist of 200 multiple choice questions of one mark each with four alternatives for each, with only one right/probable choice. There is no negative marking. The break-up of questions will be as follows:

- 5.2 The computer center based entrance test fee shall be paid through payment gateway using internet banking mode or through debit/credit card/UPI. Service charges and other taxes for transaction as applicable by bank has to be paid by the applicant.



- 5.3 The computer center based entrance test fee, once paid, will not be refunded under any circumstances. Candidates who remain absent for the entrance test will forfeit their entrance test fee.

- ▶ The candidate must note that appearance for the examination and inclusion of name in the merit list does not necessarily mean that he/she will get admission to the institute & course.
