We are pleased to inform you that the result of entrance test for admission to Master of Business Administration programme held by this University on 7th April 2024 has been declared on 15th April 2024.

Based on the rank in the entrance test and choice of Institute exercised by you, you have been provisionally allotted for admission to MBA Programme at Bharati Vidyapeeth (Deemed to be University), Institute of Management and Research, New Delhi

You are required to be physically present for counselling and on the spot admission on 22nd April, 2024 at 10.00 a.m. at Institute of Management and Research, (BVIMR), A-4, Rohtak Road, Shiva Enclave, Paschim Vihar, New Delhi 110063

It is compulsory for either you or your representative to attend the counselling to claim for admission, In this session of provisional admission, you will be called for counselling in accordance with the merit number in the regular category merit list and will be offered admission to MBA Programme as per the availability of the vacancy at that particular point of time in the counselling session. If you remain absent when your name is announced for counselling, you stand to lose claim for admission.

Important Instructions:

- 1) The following certificates in original along with two self-attested copies each of the same are to be submitted at the time of counselling and on the spot admission, (a) Statement of marks (Last qualifying examination). (b) Copy of Aadhaar card. (c) Two passport size recent photographs. The remaining documents as mentioned in the information brochure must be submitted later.
- 2) The students who are given provisional admission will be required to pay the entire amount of tuition fees of **Rs. 3,25,000/- (Rupees Three Lakh Twenty Five Thousand)** on 22nd April, 2024 at the time of admission, The above fees per annum. *(The fees shall be revised upwards @ 5% per annum)*. Semester examination fee & convocation fee are separate.
- 3) The Fee shall be paid through one of the following modes:
 - i) Online mode through our Fees portal <https://www.bharatividyaapeethfees.com>
 - OR
 - ii) Demand Draft drawn in favour of "Director BVIMR New Delhi" payable at New Delhi

To expedite and to confirm the provisional admission, you are requested to pay the fees by visiting fees portal <https://www.bharatividyaapeethfees.com> to pay the fees online. In the event of the candidate not being eligible, the fees will be refunded to the same account.

How to pay – Go to <https://www.bharatividyaapeethfees.com> click college fees - fill personal information -select campus,- select college, from drop down menu - under select faculty/course, select- under select year, select 1st year - under semester, select sem 1 - under type of fees, select tuition fees - fill the amount - click next - click payment mode and complete the transaction.

Payment can also be made through Net banking i.e. NEFT/RTGS/IMPS mode and through debit/credit card.

On payment of the fees, the provisional admission will be completed, and you will be informed accordingly.

The date and commencement of the programme and detailed timetable will be communicated to you by the respective institute.

- I) The last date for paying the tuition fee and completing the provisional admission process is **22nd April 2024**.
II) Those who have not uploaded the documents and paid the fees on or before **22nd April 2024**, will lose their claim for the admission. No further correspondence will be entertained. The consequential vacancy will be allotted to the candidates in the waiting list.

III) Instructions/steps for filling submitting application form and documents

Step 1: Visit (copy and paste URL in tab) <http://49.248.145.37:91>

Step 2: Click on Login button and enter the your registered email address.

Step 3: Enter password - Mobile Number

Step 4: The admission form will appear. Fill in admission form and fill all the required details such as Personal Details, Address Details, Parent Details, Educational Details, Other Details, Document Details, Fees Details (upload Fees receipt in jpg, png, jpeg format)

Step 5: List of documents required for filling the admission form

(Format: - jpg, png, jpeg , Size: - Should be within 300kb) –

Upload these documents –

1. Photo & Signature & Aadhar Card of a Candidate
2. Admit card of a Candidate for BMAT(MBA/MCA/MHA)-2024
3. 10th & 12th Marksheet of a Candidate
4. Previous years of Degree course Marksheet of a Candidate
5. Caste Certificate/ Caste Validity / Gap Certificate / Migration Certificate of a Candidate (If applicable)
6. Payment receipt of tuition fees paid through Online **OR** through Demand Draft of fee (If applicable)

Step 6: Click on the Submit button for submitting your application form for admission.

- IV) Student need to visit Fees portal for Payment of the fee's Online mode through our Fees portal <https://www.bharatividyaapeethfees.com> to pay the online fees and type the UTR Number on the challan and send it back.

On payment of the fees, the provisional admission will be completed. In case the candidate fails to remit the entire amount of fees, he/she will lose the claim for admission.

- 4) If you desire to have hostel accommodation, limited hostel accommodation is available on the campus both for boys and girls. The same will be allotted on first come first serve basis.
- 5) Intake of the **MBA** programme is subject to AICTE approval. As you are aware of the total intake of **MBA programme** which are mentioned in the information brochure, it may happen in the case of some candidates that admission to the Programme would be over before their turn comes up. It will then not be possible to consider them for admission, In such a situation, we do not owe any responsibility.

The commencement of the academic session for the first-year student will be informed by the institute. All students who will be given provisional admission to the respective programme have to compulsorily attend from that day.
