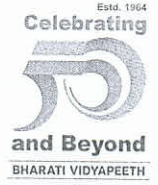

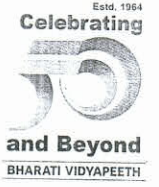

- A student can pursue two full time academic programmes in physical mode provided that class timings for one programme do not overlap with the class timings of the other programme.
- A student can pursue two academic programmes, one in full time physical mode and another in Open and Distance Learning (ODL)/Online mode; or up to two ODL/Online programmes simultaneously.
- Degree or diploma programmes under ODL/Online mode shall be pursued with only such HEIs which are recognized by UGC/Statutory Council/Govt. of India for running such programmes.
- Degree or diploma programmes under these guidelines shall be governed by the Regulations notified by the UGC and also the respective statutory/professional councils, wherever applicable.
- No retrospective benefit can be claimed by the students who have already done two academic programmes simultaneously prior to the notification of these guidelines.
- The above guidelines shall be applicable only to the students pursuing academic programmes other than Ph.D. programme.

With regard to research publications initially it has been decided to give financial incentive to those faculties who have published their research papers in SCOPUS / Web of Science / PubMed. The following is the incentive scheme :

Q1 Journals	Rs. 10,000/-
Q2 Journals	Rs. 7,500/-
Q3 Journals	Rs. 5,000/-
Q4 Journals	Rs. 2,500/-

It was further resolved that in the event of more authors, the award money should be shared equally. This award is only for the BVDU faculty. In the event of co-authors from other than BVDU, the award will be shared only between BVDU faculty.
