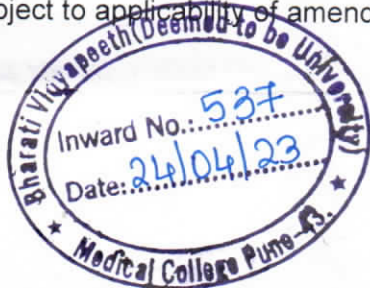

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Pharmacology) qualification for 04 seats in respect of students being trained at Bharti Vidyapeeth (Deemed to be University) Medical College, Pune under Bharati Vidyapeeth (Deemed to be University), Pune**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
