The following agenda items were taken up for discussion and consideration.

**Item No. 1**

Confirmation of Minutes of the Meeting held on 28<sup>th</sup> May, 2021.

**Resolution :**

**Minutes of the IQAC meeting held on 28<sup>th</sup> May, 2021 were read and confirmed.**

**Item No. 2**

Consideration of the report on the action taken on the decisions of the IQAC meeting held on 28-5-2021.

**Resolution :**

**Report on the action taken on the decisions of the IQAC at its meeting held on 28-5-2021 was noted.**

**Item No. 3**

To consider organizing Faculty Development Programmes and training programme for non-teaching staff during the year.

**Resolution :**

**It was resolved to conduct atleast 2 to 3 FDP for teachers as well as training programmes for non-teaching staff this year. It was resolved to request Dr. Sachin Vernekar and Dr. A. R. Bhalerao to coordinate training programmes for non-teaching staff especially for librarians working campus wise. The training may be organized in batches of 30 persons per batch and attendance should be made mandatory.**

**Further, Dr. Shirgurkar pointed out that as per the New Education Policy the university will have to offer atleast 30% of the courses as interdisciplinary subjects. He suggested that the teachers should be trained in preparation of the syllabus for interdisciplinary subjects.**

**Hon'ble Vice Chancellor informed the Committee that some of the constituent colleges including Engineering College have already offering interdisciplinary programmes.**

**Item No. 4**

Consideration of Public Notice No. 1-9/2020(CPP-ii) dated 20/5/2021 from the UGC on Blended Mode of Teaching and Learning concept – an instructional methodology, a teaching and learning approach that combines face-to-face classroom method with computer mediated activities to deliver instructions

**Resolution :**

**Hon'ble Vice Chancellor conveyed that a Committee was formed and suggestions/comments have been submitted to UGC.**

**Item No. 5**

Consideration of status of research publications in various constituent units.

**Resolution :**

**Dr. S. F. Patil stated that performance of research in some of the constituent units is not satisfactory. He mentioned that some of the constituent units need to be encouraged to undertake research.**

**Hon'ble Vice Chancellor briefed the Committee that Hon'ble Secretary had a meeting with the Heads of the constituent colleges and strictly warned them to work on improvement of research performance of their respective units.**

Consideration of sports and cultural activities to be organized in the academic year 2021-22.

**The Sports Incharge submitted tentative schedule of sports activities and will be organized in accordance with the guidelines of the Government in view of the prevalent COVID-19 pandemic situation in the country.**
