CANCELLATION OF ADMISSION AND REFUND OF FEES

1. The admission to postgraduate (MD/MS/MDS) and undergraduate (MBBS/BDS) courses offered under the Medical and Dental Faculties are done by the Directorate General of Health Services (DGHS) under the Ministry of Health and Family Welfare through Medical Counseling Committee (MCC).

The rules relating to the cancellation of admission and refund of fees in respect of the above courses are as detailed below:

(a)	Amount to be forfeited in case of resigning the seat due to up-gradation during the 2nd round of counseling.	Rs. 10,000/-
(b)	Amount to be forfeited in case of resigning after the 2nd round of counseling and allotment.	The entire fee will be forfeited as no candidate is permitted to resign after the 2nd round of counseling as per the judgement of the Hon'ble Supreme Court of India
(c)	Amount to be forfeited in case of resigning after the allotment MOP-UP round.	The entire programme fee has to be paid after adjusting the fee already paid.

Note:

- 1. The resignation letter should be addressed to the Principal of the concerned college and acknowledgement has to be taken in proof of the submission of the letter.
- 2. All disputes with regard to admission to Postgraduate and Undergraduate programes of the Medical and Dental is subject to the Pune Jurisdiction only.

2019 General Category Program Fee Refund Rules

If the student chooses to withdraw from the program of studies in which he/she is enrolled, the refund of the fees paid will be made as per the following UGC guidelines.

Sr. No.	Percentage of Refund of Aggregate fees *	Point of time when notice of withdrawal of admission is submitted to the University	
1.	100% **	15 days or more, before the formally-notified last date of admission	
2.	90%	Less than 15 days before the formally-notified last date of admission	
3.	80%	15 days or less, after the formally notified last date of admission	
4.	50%	30 days or less, after the formally notified last date of admission	
5.	0%	More than 30 days after the formally notified last date of admission	

^{* (}inclusive of course fees but exclusive of caution deposit)

- In case of (1) in the table above, the University shall deduct Rs. 5,000/- as processing charges from the refundable amount.
- Any student who withdraws from the course as mentioned in Sr. No. 5 and thereafter will be required to remit to the University, in addition to the amount already forfeited, the course fee payable for the remaining period of the course.
- In case of Foreign/NRI candidates, the refund will be made in accordance with RBI/Foreign exchange regulations.
- All refunds will be processed by the respective units of the University upon receiving the approval from the Registrar based on the recommendation of the Head of the Institution. Refund will be made only after the candidate has surrendered the ID card, original fee receipt and the dues clearance certificate.
