With reference to the subject cited above, I am hereby directed to inform to all the concerned that:-

- The Cut-off date for admission into under graduate courses of Homoeopathy system for the academic session 2023-24 shall be 18th Nov. 2023.
- The date of Commencement of Under-Graduate courses of Homoeopathy system for the Academic Session 2023-24 shall be 1st Nov. 2023.
- All counselling authorities are requested to schedule the counselling process of all the rounds appropriately so that entire admission process shall be completed on or before 18th Nov. 2023 for Academic Session 2023-24.
- The decision of The National Commission for Homoeopathy shall be final and binding for all the stake holders.
- Admissions by any means after the cut-off date shall not be approved.
- Institutes shall be held responsible for any irregular and illegal admission (admission without NEET eligibility, admission without counselling/admission authority, admission beyond permitted intake capacity, admission beyond cut-off date etc). In such cases the student shall be discharged from the course and the institute will be penalized as per the provision of Sub-Section (f) of Section 28(1) of NCH Act 2020.
