Choice based Credit System

The choice based credit system encourages student participation in the academic programmes, allows for credit accumulation and transfer within the faculties and among Universities. It provides uniformity in performance indicator across Universities.

Vocabulary:

Teaching-Learning Process

- Programme: A unit of study that a student undertakes that leads to certification (i.e. MCA)
- Course: The smallest unit of assessment in a programme (i.e. subject)
- Credit: A measure of effort required from a student to learn a course
- One Credit equals to: 15 Hours of Lectures / 30 Hours of Laboratories / 30 Hours of Field Work / 30 Hours of Minor Project / 20 Hours of Internship

Categories of Courses

- Core Courses: Courses corresponding to topics on the discipline of study
- ▶ Elective Courses: Courses corresponding to specializations
- Open Courses: Courses from other disciplines necessary for understanding core courses (e.g. mathematical courses, IT courses etc.)

- Grade Point Index (GPI): Performance indicator for a given course (GPI = GP Correspondence total means UE and IA)
- Semester Grade Point Average (SGPA): Overall performance indicator for a semester
- Cumulative Grade Point Average (CGPA): Cumulative performance indicator up to a given semester
- Award of Class: On the successful completion of programme the final CGPA is mapped against a respective class

2 ELIGIBILITY

2.1 MCA (Two Years Full Time)

Passed B.C.A/B.Sc. (Computer Science)/B.Sc. (IT) / B.E. (CSE)/B.Tech. (CSE) / B.E. (IT) / B.Tech. (IT) or equivalent Degree.

OR

Passed any graduation degree (e.g.: B.E. / B.Tech. / B.Sc / B.Com. /B.A./ B. Voc./ etc.,) preferably with Mathematics at 10+2 level or at Graduation level

Obtained at least 50% marks for open category (45% marks in case of candidates belonging to SC/ST category) in the qualifying examination. (for students having no Mathematics background compulsory bridge course will be framed by the respective University/ Institution and additional bridge courses related to computer subjects as per the norms of the concerned University).

Note: Candidates who are presently studying in the final year of Bachelor's degree programme can also appear for the entrance

test and seek admission for MCA programe in the year 2025-26. However, They are eligible for admission only if

- (a) the basic qualification mentioned in 2(I) above are full filled.
- (b) The last date to submit all the certificates in original shall be **30th September 2025**. If the certificates are not submitted by the said date, the eligibility will not be granted and the admission would automatically stand cancelled.

The candidate should be an Indian national.

3. BASIS OF SELECTION FOR ADMISSION

- 3.1 A Candidate desirous of seeking admission to MCA Programme should fulfill the minimum eligibility condition as stated in point no. 2 above. The final admission will be offered based solely on the merit obtained at the all India **B-MAT-2025** entrance test conducted by Bharati Vidyapeeth (Deemed to be University), Pune.
- 3.2 He/She must have appeared for the **B-MAT-2025** entrance test, conducted by Bharati Vidyapeeth (Deemed to be University), Pune at designated centres.
- 3.3 The Candidate shall be offered admission on the basis of his/her rank in the final merit list and availability of the seats for a particular programme at a particular Institute of the candidate's choice at the time of counseling and admission in the concerned Institute. Mere appearance in the entrance test and inclusion of name in the merit list does not confer any automatic rights to secure admission to the programme offered by the institute. The selection and admission to the programme is subject to fulfilling the eligibility criteria.

- 3.4 In the case of candidates securing equal aggregate marks their relative rank will be determined on the basis of following order of preference:
 - a) If equal, the candidates will be ranked according to their percentage of marks obtained at HSC or its equivalent examination.
 - b) If equal, the candidates will be ranked according to their percentage of marks scored at SSC or its equivalent examination.
 - c) When all the above scores are the same, the candidates will be ranked on the basis of computerized random numbering.

All candidates desirous of taking admission for MCA Programme must appear for **B-MAT-2025**

- 4.1 The **B-MAT-2025** is a entrance test for admission to MCA Programme. It will be of 200 marks and shall be of 180 minutes duration.
- 4.2 The entrance test **B-MAT-2025** for admission to MCA Programme will consist of in all 200 marks. It consists of 200 multiple choice questions one mark each with four alternatives, with only one correct or most appropriate answer. One Mark will be awarded for each correct answer. 5. ENTRANCE TEST FEE:
