1. GENERAL

The students will be admitted to the four year full time Engineering degree programmes of the College of Engineering, Pune and Department of Engineering and Technology, off campus Navi Mumbai on the basis of the merit obtained by them in the All India Common Entrance Test **CET (ENGINEERING)-2025** conducted by the Bharati Vidyapeeth (Deemed to be University), Pune.

Note :

- **Foreign National/ PIO/ OCI/ NRI/ Institutional Quota Merit Seats :**

Fifteen percent (15%) of the sanctioned intake in each branch are reserved for Foreign/NRI(Non-Resident-Indian)/P.I.O./O.C.I./ Institutional Quota Merit Category students. Candidates seeking admissions to the seats of this category will have to apply to **The Registrar, Bharati Vidyapeeth (Deemed to be University) Pune, India**. The Form fee for this category is **RS. 1,000/- (non refundable)**. Seats remaining vacant after allotment to Foreign / N.R.I. / P.I.O. / O.C.I. merit students will be allotted to Indian students under Institutional Quota Merit Category on the basis of marks obtained by them in the **BV-BTECH-2025**. The last date for submission of the forms for this category is **9th June 2025 before 5 p.m.**

All the candidates seeking admissions will have to appear for Entrance Test **BV-BTECH-2025**. conducted by Bharati Vidyapeeth (Deemed to be University), Pune. All candidates will have to apply online & fill the prescribed application form at the website : www.bvuniversity.edu.in

- **Concession for the ward of Kashmiri Migrants and Kashmiri Pandit /Kashmiri Hindu Families[Non-Migrants] living in Kashmir valley for admission in Higher Education Institutions.**

As per circular No. F.No.3-4/2017-NER, Government of India, Ministry of Human Resource Development, Department of Higher Education, Economic Administration Division, dated **15th October 2019**, concession for the ward of Kashmiri Migrants and Kashmiri Pandit /Kashmiri Hindu Families[Non-Migrants] living in Kashmir valley for admission in Higher Education Institutions.

- Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirements.
- Increase in intake capacity upto 5% course-wise.
- Reservation of at least one seat in merit quota in technical/professional institutions.
- Waiving off domicile requirements for Kashmiri migrants only. Kashmiri Pandits/Kashmiri Hindu families [Non-Migrants] living in the Kashmiri Valley need domicile certificate.

2 ELIGIBILITY FOR APPEARING IN BV-BTECH-2025

Only those candidates who satisfy or are likely to satisfy the relevant eligibility requirement for admission to the courses will be considered to appear for the entrance test BV-BTECH-2025

Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the subjects Chemistry / Biotechnology / Biology / Technical Vocational subject / Computer Science / Electronics / Information Technology / Informatics Practices / Agriculture / Engineering Graphics / Business studies / Entrepreneurship and obtained at least 45% marks (40% marks, in case of candidates belonging to SC/ST category and Persons with Disability) taken together.

For Civil, Chemical and Mechanical Engineering, candidates who have studied and passed in Chemistry along with the subjects Physics and Mathematics will be given preference.

OR

Passed minimum 3 years / 2 years (Lateral Entry) Diploma examination with at least 45% marks (at least 40% marks, in case of candidates belonging to SC/ST category)

OR

Passed three years D.Voc. Stream in the same or allied sector.

3. BASIS OF SELECTION FOR ADMISSION

- 3.1 A Candidate desirous of seeking admission to B.Tech.(Engineering) Programme should fulfill the minimum eligibility condition as stated in point no 2, above.

- 3.2 He/She must have appeared for the entrance test **BV-BTECH-2025** conducted by Bharati Vidyapeeth (Deemed to be University), Pune at designated centres.
- 3.3 The candidates whose names appear in the list prepared on the basis of marks obtained by them in **BV-BTECH-2025** should attend the Counselling and on-the-spot admissions sessions to the various branches and courses as per their ranks in the merit list. The Counselling schedule of combined for all branches will be notified at www.bvuniversity.edu.in. Mere appearance in the entrance test and inclusion of name in the merit list does not confer any automatic rights to secure admission to the programme offered by the institute. The selection and admission to the programme is subject to fulfilling the eligibility criteria.
- 3.4 In case two or more candidates obtain equal marks in the **BV-BTECH-2025**, the inter rank of such candidates shall be determined in order of preference as under :
- Candidates obtaining higher marks in Mathematics in the entrance test.
 - Candidates obtaining higher aggregate percentage of marks in H.S.C./equivalent examinations
 - Candidates obtaining higher percentage of marks in Mathematics in the 10th standard examination.
 - In case of tie at this level, computerised random selection of candidate will be carried out.

4. NATURE OF ENTRANCE TEST "BV-BTECH-2025"

The **BV-BTECH-2025** is a entrance test for admission to B.Tech Programme will consist of in all 200 marks.

- 4.1 The Computer centre based Entrance Test **BV-BTECH-2025** for admission to B.TECH. (Engineering) Programme will be of 200 marks. The examination consists of one question paper set in English medium and will consist of 200 multiple choice questions with four alternatives, with only one correct or most appropriate answer. One Mark will be awarded for each correct answer. It will consist of 80 questions on Mathematics, 60 questions on physics and 60 questions on Chemistry. The duration of the examination is of 3 hours.
