The custodians who were allotted the work of accepting question paper through online system for regular examinations shall accept the question paper for this examination also.

The students of undergraduate programmes who have been taught this subject by or under the guidance of the Director, BVDU Inst. of Environment Education and Research, Pune are eligible to appear in this examination.

The Central Assessment Programme (CAP) will be conducted at respective Colleges / Institutes on **15th July, 2025** where the examination is conducted and the results in the form of either pass or fail should be submitted to the University by **17th July, 2025**. The Principal / Directors of the College / Institutes are requested to make arrangement for the CAP as like any other University Examination and are also requested to appoint one Senior Professor as CAP Director under intimation to the University.

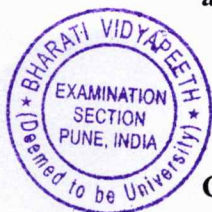
