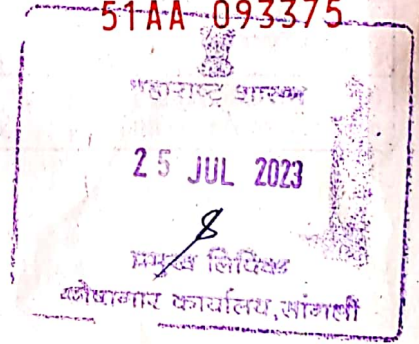

MEMORANDUM OF UNDERSTANDING

This memorandum of Understanding is executed on August 21, 2023 at Sangli between (Shri Siddhivinayak Ganapati Cancer Hospital, Sangli Road, Miraj- 416410) here in after referred to as party of the 1st part which includes its heirs, assignees, executors, administrators etc.

AND

Bharati Vidyapeeth Deemed to be University, Pune registered office LBS Marg Pune through its Dr.Mrs. Nilima Rajan Bhore, Dean Faculty of Nursing and Principal, Bharati Vidyapeeth Deemed to be University, College of Nursing, Sangli, here in after referred to as party of the 2nd part.

The party of the 1st part is heading a hospital in the name Dr. D. K. Gosavi Memorial, Shri Siddhivinayak Ganapati Cancer Hospital, Sangli Road, Miraj-416410, a reputed, full-fledged Cancer Hospital which provides comprehensive care to meet the need of the poor and rural community of the area, particularly those who are suffering from Cancer and are under the shadow of this dreaded disease.

The party of 2nd part is Dr. Mrs. Nilima Rajan Bhore, Dean Faculty of Nursing and Principal, Bharati Vidyapeeth Deemed to be University, Pune, College of Nursing, Sangli, is functional since 2007. The college is running 3 courses in nursing respectively, B.Sc. (N), Post Basic B.Sc. (N) & M.Sc. (N).

Now this Memorandum of Understanding is executed incorporating the following terms & conditions:

1. The party of the 1st agrees to have an academic MOU with the part of the 2nd part to the extent of educational support in the form of clinical exposure & training to the students of part of the 2nd part i.e. Dr. Mrs. Nilima Rajan Bhore, Dean Faculty of Nursing and Principal, Bharati Vidyapeeth Deemed to be University, College of Nursing, Sangli. This will include access to the facilities of the party of the 1st part like nursing procedures to nursing students during their regular clinical experience and during their internship as the guidelines of INC / MNC.
2. The nursing students of the party of 2nd part while visiting the party of the 1st part will be accompanied by their teachers who will take full responsibilities of the educating their students availing the facilities for the party of the 1st part. The students of the party of the 2nd part will strictly abide by the rules of the party of the 1st part and any kind of violation thereof will lead to denying the facilities available with the party of the 1st part. Any damage caused by any students to the property of clinical facilities of the party of the 1st part will be compensated by the party of the 2nd part.
3. Both parties shall have unequivocal right to bring an end to the agreement without assigning any reason or without any prior notice and the party 1 or Party 2nd will not be entitled to any claim by way of compensation and / or damages.
4. The party of the 2nd part shall not make any endeavors to have covetous gain from this agreement. This agreement is entered by both the parties only for the sole purpose of "service to mankind"
5. The students of the party of the 2nd part shall not be allowed to deal with the patients of party of the 1st part directly
6. Since the party of the first part is having qualified staff as per its requirement the party of the 2nd part can avail the clinical exposure from them at the time of their training.

This agreement shall remain in forces for five years effective from the date execution of this MOU. It can be further extended by mutual agreement of both parties.
