- 5. Foundation will also help organise visits to various industries and BVDUCoNSangli will do health screening of the workers, educate the work force and the management about health hazards and mitigating measures which can be adopted etc.

- 7. Foundation will extend all help other than financial involvement in all research works undertaken by BVDUCoNSangli.
