- · Mode of Payment of fees:
 - o a) Demant Draft in the name of "Principal, Poona College of Pharmacy" (You must carry Demand Draft at the time of counselling) or
 - o b) Online payment mode.
 - The cancellation of the admission and fees refund will be as per the UGC guidelines issued by UGC by time to time.

COUNSELLING PROCEDURE:

- A. Report to the counselling venue on time and sign the attendance sheet.
- B. Collect the counselling form, fill up the same and occupy the chair as of your merit number.
- C. Arrange all the original certificates and two sets of photocopies (refer to the list documents given below)
- D. Attach one set of photocopy to the filled counselling form.
- E. Verify your original documents and filled counselling form from the Verification Authority.
- F. Wait patiently until you will be called for the Counselling as per the merit number.
- G. You should follow the following sequence in the process and sign in the presence of the Counselling Committee.
 - a. Counselling and allotment of Seats
 - b. Payment of full fees.
 - c. Submit original certificates along with two photocopy sets.
 - d. Fill the given provisional admission form and eligibility certificate.
 - e. Candidate registration on ERP
- H. It is essential that you follow all the steps in the process. Announcements for the call for Counselling will be made every half an hour. Any person reporting late i.e. after 09.00 am will be considered after the completion of half hourly admission process, after his / her reporting. If an authorized representative is attending the Counselling, he / she should occupy the seat of the candidate and keep authority letter and other necessary certificates and papers ready for Counselling. In case of any difficulty, you should report to the In-charge of Counselling Committee and the decision of the committee will be final.
