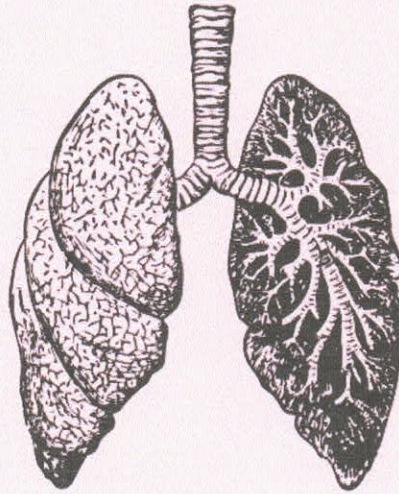

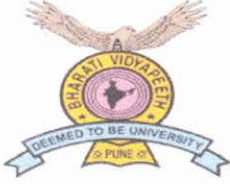

Three groups were announced as winners based on different aspects such as organization, content, presentation skills and question and answer session. The winners were appreciated by a certificate.



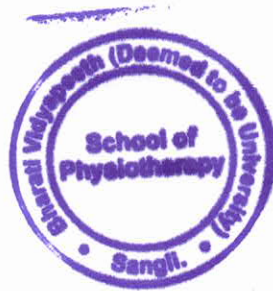
