A dental screening camp was arranged by Bharati Vidyapeeth Dental College & Hospital, Sangli at Central Jail, Sangli . After the official formalities, consent was obtained from the higher authorities. A team consisting of 7 interns was assigned to deliver the services through an outreach program. The team left the college on 22-01-2025 at 9:00 A.M. and reached the venue at 9:30 A.M. The screening of subjects started at 10:00 A.M. and continued until 04:00 P.M. Total 74 subjects were screened and Colgate toothpaste was distributed. For some patient's treatment was given in Mobile Dental Van, Ultrasonic Scaling of 15 patients, Composit Restoration 0, Pit and Fissure Sealant 0, Fluoride Application 0, were done. Remaining patients suffered from severe Dental Caries, calculus & Malocclusion. Subjects requiring the treatment were referred to BVDU Dental College and Hospital for needful treatment at concessional cost. Referral cards were given to the patients for the discount in the treatment procedures. The team left the venue at 04:00 P.M. and reached the college at 04:30 P.M.
