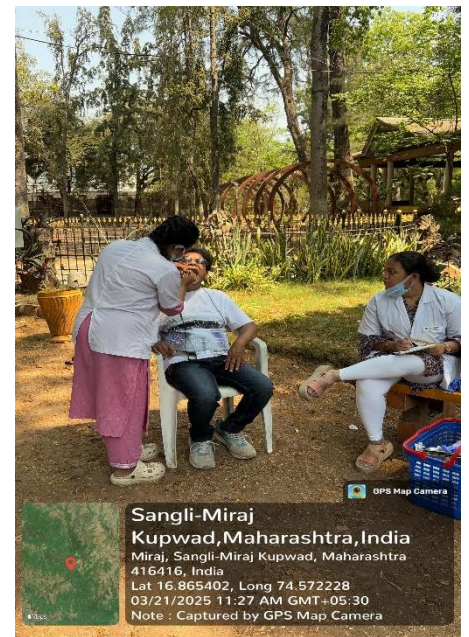

On 21/03/2025 a treatment camp was arranged by Bharati Vidyapeeth (Deemed to be University) Dental College and Hospital, Sangli at Amrai Garden Sangli on the occasion of "INTERNATIONAL FORESTRY DAY". After the official formalities, consent was obtained from the higher authorities. A team consisting of 5 interns, 4 Second year students and 01 Assistant Professor were assigned to deliver the services through an outreach program. The team left the college on 21-03-2025 at 10:00AM and reached the venue at 10:30 AM. Skit was performed on topic –Awareness regarding Forests. Tree plantation was done by Topper of Final year BDS Student on occasion of Forestry Day. The screening of Patients started at 11:30 AM and continued until 1:00 P.M. Total 36 subjects were screened. They mostly suffered from dental caries, missing teeth and periodontal diseases. After Screening 6 Patients were treated for stains and deposits with Scaling Treatment. Tooth brushing technique was explained with the help of brushing model. Subjects requiring the treatment were referred to BVDU Dental College and hospital for needful treatment at concessional cost. Referral cards were given to the patients for the discount in the treatment procedures along with free toothpastes. The team left the venue at

1:30 P.M and reached the college at 2:00 P.M. This camp report is compiled by- Ishwari Patil [Intern].
