2. Class 10th and 12th Mark sheets (Two sets of self- attested photocopies)
3. Graduation Mark Sheets (Original + Two sets of self-attested photocopies)
4. Migration Certificate (from the last qualifying University) (Original + Two Sets of self-attested photocopies)
5. Provisional Certificate (Original + Two sets of self-attested photocopies)
6. Transfer Certificate (Original + Two sets of self-attested photocopies)
7. Caste Certificate (for SC/ST/OBC candidates) Two sets of self-attested photocopies
8. Domicile Certificate (for candidates from other States) Two sets of self-attested photocopies
9. Aadhaar Card -Two sets of self-attested photocopies
10. Gap Year Certificate (if applicable) -To be submitted if there is an educational gap of **one year or more, on ₹10 stamp paper**, duly notarized by a Notary Public.

12. ABC ID (APAAR ID) Self-attested photocopy

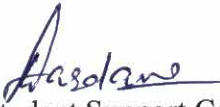

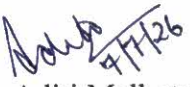

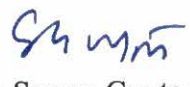
