8. Gap Year Certificate (if applicable) -To be submitted if there is an educational gap of **one year or more, on ₹10 stamp paper**, duly notarized by a Notary Public.

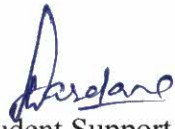
