- **Website:** Dr. Pravin Mane briefed about the updation of website.
- **Examination:** Dr. Mahadik discussed about the schedule of Examination and continuous Evaluation System followed at IMED.
- **Digital Library:** Dr. Sachin Ayarekar explained the e resources available at IMED. He also shared the e resources utilization report which was increased a lot by students and faculty members.
Dr. Jayant Oak gave suggestion to share the e resources to alumni.

- **NIRF Ranking and AQAR:** (Dr. Sonali Dharmadhikari discussed about NIRF ranking. IMED has been ranked amongst top 75 B-schools for last 6 years consistently. This year also the data for NIRF has been uploaded on time. She informed about AQAR Cri IV consolidation was assigned to IMED by university.

Dr. Shyam Shukla updated about the status of work for NBA accreditation. He informed that Dr. Sachin Vernekar has been selected as Margdarshak for NBA Accreditations by AICTE. All committee members appreciated it.

Agenda 6: Any item with the permission of chair:


As a special item, Dr. Sachin S. Vernekar focused on implementation plan of NEP 2020 at University level.

He briefed on the implementation plans for the following points:


1. Amendment of Institutions (Deemed to be University) Regulations to facilitate vocational education.





Date: 18th August, 2021: From 2:00 pm to 6:00 pm.


