Minutes of HOD meeting (12 March 2022)

- Azadi ke 75 saal - 'Azadi Ka Amrit Mahotsav'** is an initiative of the Government of India to celebrate and commemorate 75 years of independence of progressive India. In this regard, the list of activities which were submitted to Principal's office shall be conducted at the department level and a detailed report of the said activity shall be submitted to Principal's office.
- Amendments in 2021 course structure** – Discussion regarding the amendments in 2021 course structure is carried out in the meeting. It is proposed in the meeting that total credits for each semester will be 25, total marks will be 750 and the teaching scheme will be of 27 to 30 hrs and 31 hrs in some cases. For semester I and II, it is proposed that number of programs having physics and chemistry courses shall be equal in numbers which are unequal in earlier course structure. In semester-III course structure, it is proposed that vocational course will be given 1 practical turn per week and 1 credit will be allotted for the same. MOOC course will be outside the structure and additional 2 credits will be allotted after completion of the MOOC course and submission of certificate. Environmental studies will be a compulsory course for which 2 hrs will be allotted in teaching scheme. Total 50 marks will be allotted for environmental studies course which will not be considered in final grade calculation. In semester IV, 1 practical turn per week and 1 credit will be allotted for vocational course. Social activity will not be a mandatory course and additional 2 credits will be allotted for the same. Term work and Viva will be split up and separate marks will be given for the same. In semester V, for vocational course, 2 practical turns per week and 1 credit is proposed for all programs. The project stage – I mentioned in earlier course structure is proposed to be cancelled as mandatory PBL topics are added for every semester. Additional credit for MOOC course in semester V is proposed. In semester VI, for quantitative techniques communication and values course, weekly 4hrs are proposed in teaching scheme, out of which 2 hrs will be for quantitative techniques and 2 hrs will be for communication and

values. Total 4 credits are proposed for the same. The practicals for the course are removed from the structure and internship mentioned in earlier course structure is proposed to be shifted to semester VII to limit the duration of the semester VI. In semester VII, 60 days internship is proposed which was earlier for 45 days and 3 credits are proposed for same. Project stage – I is proposed in semester VII and 2 practical turns per week will be allotted for same. Term work and oral examination will be assessed for 50 marks each and 3 credits are proposed for same. For MOOC course in semester VII, 2 additional credits are proposed. In semester VIII, 4 practical turns are proposed for project stage – II. 100 marks for theory and 100 marks for oral examination are proposed. Research papers published in semester VIII will be given additional credits. For Social activity performed additional 2 credits are proposed. Above amendments are proposed for the implementation, execution and benefits of students.
