The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in Under Graduate (BHMS) course with student intake of 100 seats in UG (BHMS) course & 30 seats in PG [MD (Hom)] for the academic year 2022-23.

- 2. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college were examined as per the existing regulations.
- 3. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:
- 4. That the applicant has set up the Homoeopathic Medical College and teaching Hospital with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to implement Minimum Standard Requirements of the Homoeopathy college and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting undergraduate and post-graduate courses in Homoeopathy.
- 5. After considering the provisions of NCH Act, 2020 the permission of the Medical Assessment and Rating Board for continuing admission is granted to Bharati Vidyapeeth Homoeopathic Medical College, Bharati Vidyapeeth Educational Campus, Katraj-Dhankawadi, Maharashtra, Pune-411043 with intake capacity of 100 seats in BHMS course and 30 seats for MD (Hom) course in 05 subjects namely Materia Medica, Organon of Medicine, Repertory, Pharmacy and Practice of Medicine with 06 seats each for the academic year 2022-23.
- 6. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' and all admissions in Post Graduate course shall be through 'All India Ayush Post Graduate Entrance Test (AIAPGET)' only. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.
- 7. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State / UT. 100% Under Graduate & Post Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counseling of seats under All India Quota shall be conducted by Central Government.

8. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.

Bharati Vidyapeeth Homoeopathic Medical College, Maharashtra, Pune-411043 is functional since 1995 and has submitted an application for permission for sanction of 100 seats in UG (BHMS) course and 30 seats for PG [MD (Hom)] course in 05 subjects namely Materia Medica, Organon of Medicine, Repertory, Pharmacy and Practice of Medicine with 06 seats each for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following shortfalls are noticed for immediate rectification:

Teaching Faculty-

For UG: There is a discrepancy in the information of Associate Professor in the dept. of Materia Medica. Details of Associate Professor in the dept. of Materia Medica is not provided in teaching faculty information, however it is shown in the teaching staff of Part-1 submitted by the College.

For PG:

- a. There is a discrepancy in the information of Assistant Professor in the dept. of Organon. Details of Assistant Professor in dept. of Organon is not provided in teaching faculty information, however it is shown in the teaching staff of Part-1 submitted by the College.
- Associate Professor in dept. of Organon, Materia Medica, Repertory, Pharmacy, Practice of Medicine are not available.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria

Therefore, Medical Assessment and Rating Board for Homoeopathy has decided to issue conditional permission to Bharati Vidyapeeth Homoeopathic Medical College, Bharati Vidyapeeth Educational Campus, Katraj-Dhankawadi, Maharashtra, Pune-411043 for conducting BHMS course with student intake of 100 seats in UG (BHMS) course and 30 seats for PG [MD (Hom)] course in 05 subjects namely Materia Medica, Organon of Medicine, Repertory, Pharmacy and Practice of Medicine with 06 seats each for the academic year 2023-24.

College is directed to provide the department wise University approved guidelist and their student allocation for verification.

The shortfalls observed in your College shall be rectified within a period of 15 days or before counselling initiates whichever is earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that 100% of seats of the permitted intake capacity of UG (BHMS course) and PG {MD(Hom.)} Scourse shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
