On 23/01/2024 a dental screening camp was arranged by Bharati Vidyapeeth (Deemed to be University) Medical College and Hospital, Sangli at- Hindkesari Ganpatrao Andhalkar high-school Andhali Palus . After the official formalities, consent was obtained from the higher authorities. A team consisting of 4 intern and 01 Professors were assigned to deliver the services through an outreach program. The team left the college on 23-01-2024 at 9:30 AM and reached the venue at 10:30 AM. Health talk given on topic -Dental caries. The screening of Patients started at 10:30 AM and continued until 3:00 P.M. Total 345 subjects were screened. They mostly suffered from dental caries, missing teeth. Tooth brushing technique was explained with the help of brushing model. Subjects requiring the treatment were referred to BVDU Dental College and hospital for needful treatment at concessional cost. Referral cards were given to the patients for the discount in the treatment procedures along with free toothpastes. The team left the venue at 3:30 P.M and reached the college at 5:00 P.M. 
