#### **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is made at Pune on 21<sup>st</sup>December 2023 between Bharati Vidyapeeth (Deemed to be University) College of Nursing, Dhankawadi, Pune-411043, India. Hereinafter referred to as "BV(DU) CON" (Which term shall so far as the context admits be deemed to mean and include its successors and assigns) of the First Part, and GTT Foundation Non-Profit Organization has its registered office at 10, Talera Park, Kalyani Nagar, Pune-411014 hereinafter referred to as "GTTF" (which expression shall, unless it be repugnant to the subject or context thereof, include its successors and permitted assigns) of the Second Part.

- 3. The Institute shall share in their letter head the details of the students who will attend the aforesaid training program with GTTF like Name, Email ID, Aadhar card,contact details, Name of the Company in which Candidate is currently placed, designation and placement proof (current Company), qualification (along with the year of completion/pursuing) and other documents as per GTTF training requirements.
- 4. Minimum Hundred (100) Students are expected to undergo the training program for each year.
- 5. The Institute shall use the logos /names of GTTF only for the purpose of the training as agreed in this LOU. The Institute shall keep GTTF aware about the usage of GTTF's logo and name.

### **Roles & Responsibilities of GTTF:**

- 1. GTTF shall provide the handholding of the trained candidates through mentoring process.
- 2. GTTF will arrange for assessment of its own and also arrange external assessment as required.
- 3. This life skills enhancement training program is free of cost. GTTF shall not charge any fees on whatsoever account/name from the students or the Institute for conducting the aforesaid training program. Certificates shall be awarded by GTTF to the students on successful completion of the training and clearing of the assessment held post completion of the training program.
- 4. Any alteration / modification to this letter shall be mutually discussed and agreed upon in writing.
- 5. All intellectual or proprietary property and information, supplied or developed by either Party shall be and remain the sole and exclusive property of the Party who supplied or developed same. Upon termination of this MoU and upon written request, the Party in receipt of the requesting Party's intellectual or proprietary property and/or information pursuant to this MoU shall return such information to the requesting Party.
- 6. Both parties undertake to each other to keep confidential all information (written or oral) concerning the business and affairs of the other, which has been obtained or received during the course(s) of performance hereunder, save that which is inconsequential or obvious.
- 7. The Institute agrees that during the term of this Agreement and for a period of three (3) years after the termination or expiry thereof, it shall not, directly or indirectly, employ, contract, solicit, hire or otherwise utilize the services of an existing employee of GTTF.

8. Any dispute arising out of, in relation to or in respect to this MoU shall be settled through mutual consultation and agreement, by the Parties to this LOU. In case a settlement is not arrived at within fifteen (15) days of reference, the dispute/s shall be referred to a sole arbitrator to be appointed in accordance to the Arbitration and Conciliation Act, 1996 as amended from time to time. The place of arbitration shall be Pune, India.
