The data collected from the Google Sheet was then analyzed using Excel. This process allows educators to make informed decisions and tailor their teaching approaches based on student input.

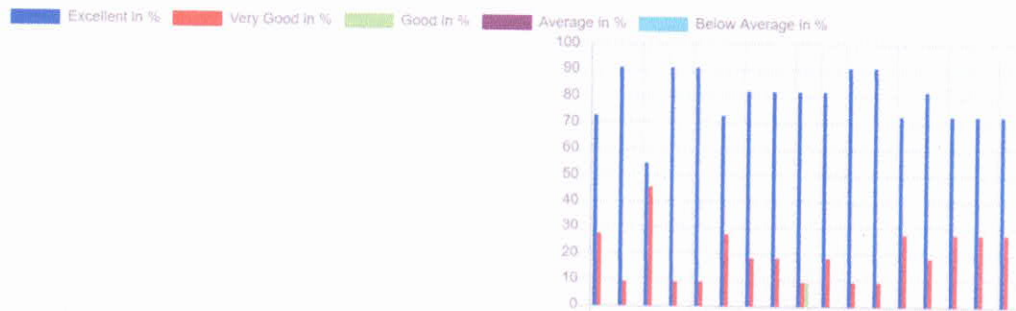
The questions covered all the aspect of the cirriculum that would assist in examining the current cirriculum and help in the improvisation in future if needed.

Total of 147 Students filled the form. Total of 17 questions were formulated and a likert scale with options, excellent, very good, good, average and below average was used for the grading.

The commonest response given by the Physiotherapy students were 'excellent (4)', 'very good (3)', 'good' (2).

More than 90% of the student were overall satisfied with the current cirriculum.

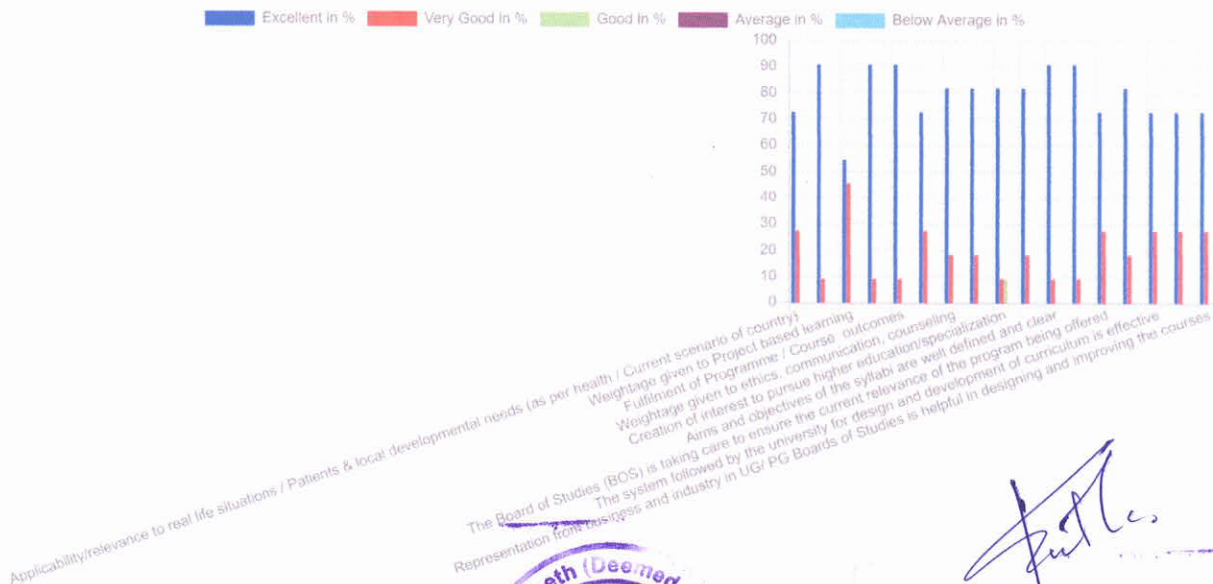

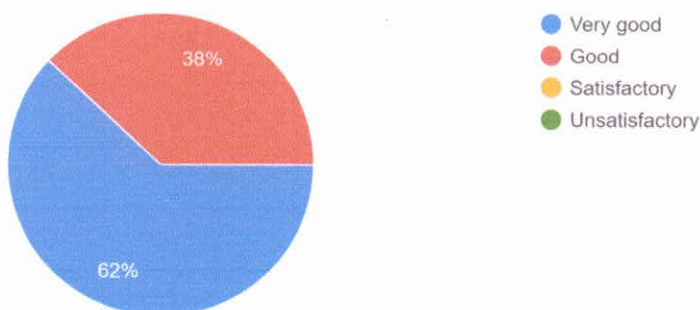
PARENTS FEEDBACK ANALYSIS (YEAR 2023-24)

Parents were given a feedback form which had questions regarding the physiotherapy course.

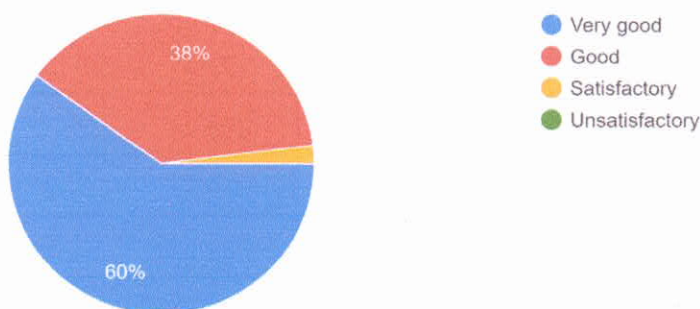
Total of 50 parents participated in the survey. Total of 10 questions were formulated and a likert scale with options, Very good, Good, Satisfactory and Unsatisfactory.

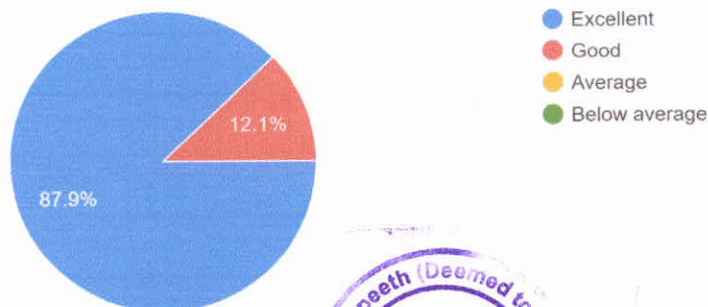

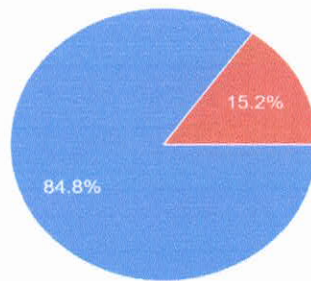

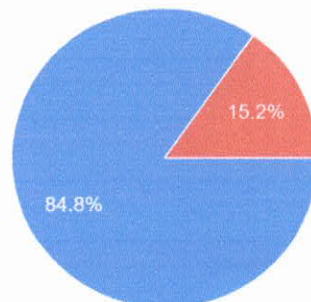
