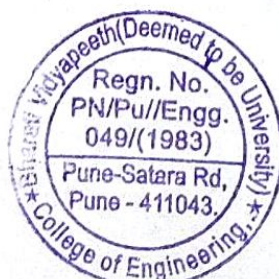
**National Innovation and Start up Policy (NISP) Committee 2021-2022**
