- 5) According to the directions received from Ministry of Human Resource Development, Ref letter dated 10/5/2018, we have to establish one section of the Library in each






Discussion & Deliberation


- 1) 134 textbook with reference books have been purchased of various specialties at the cost of Rs.1, 43,813/-.
