- Promoting drug proving.

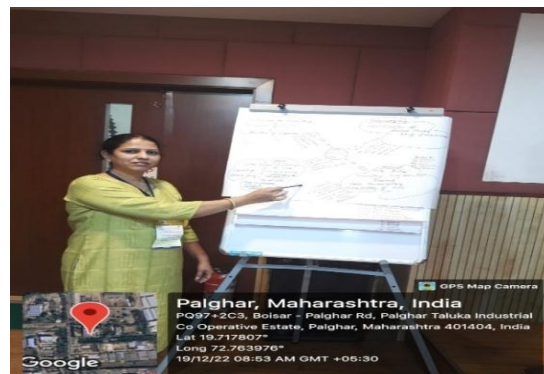
Overview of 6 days CME Program:
