#### Important Instructions

- 1 You are instructed to bring with you all relevant documents (original and two sets of attested copies of each).
- 2 The students who are given provisional admission to M.Pharm. will be required to pay tuition fee **Rs.1,75,000/- Per Annum + Contingency Rs.15,000/- + Rs.1,000/- 'Caution Deposit'** at the time of Admission.
- 3 The students who are given provisional admission to Pharm.D. (PB) will be required to pay tuition fee **Rs.1,75,000/- Per Annum + Rs.1,000/- 'Caution Deposit'** at the time of admission.
- 4 You will be required to pay the entire amount of fees at the time of admission.

The Fees should be paid through Demand Draft of any nationalized bank drawn in the name of "Principal, Poona College of Pharmacy, Pune Payable at Pune

As you are aware of the total intake of first year of M. Pharm / Pharm.D (PB) Programme, it may happen in the cases of some candidates that admission to the programme would be over before their turn comes up. It will then not be possible to consider them for admission to the programme. In such situation we do not owe any responsibility.
