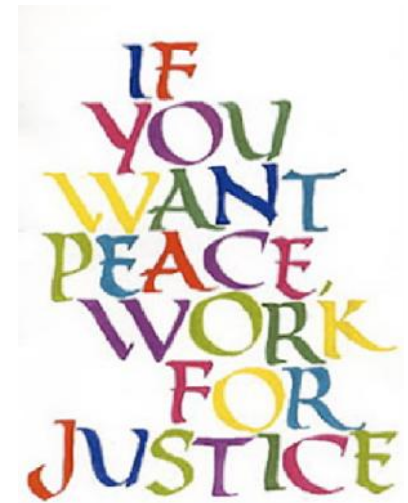

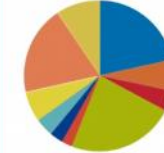

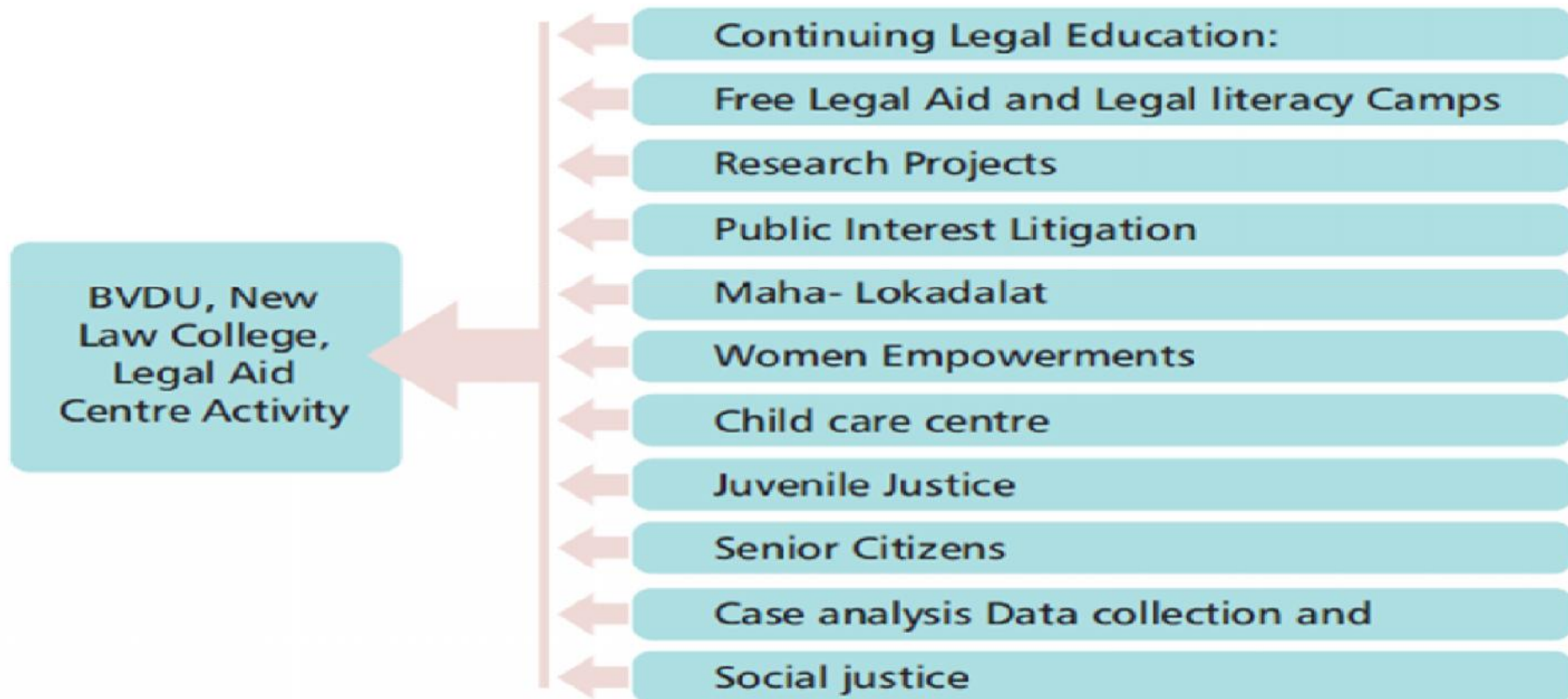
### Object of Legal Aid :
